• In Thursday's trading session, the nifty opened on a negative note and continued to trade in the red zone in the first half of the trading session, in the second half the Bulls managed to gain momentum which helped the index to close on a positive note for the fifth consecutive trading session.

- On a daily scale, the index has formed a strong bullish candle at the support of 20 DEMA which helped the index to cover up the gap that was created on the 15th of April. RSI resumed its journey in the north direction which indicates good strength in the index.
- For Friday's trading session, 22,600 will act as an initial resistance level, and on the lower end, 22,470 will act as an initial support level.

BANKNIFTY – 48,494.95 (Daily Chart)



• In Thursday's trading session, the banking index opened on a negative note but managed to recover from the lower level which helped the index to move in the green zone and closed on the positive note for the fifth consecutive trading session.

• On a daily scale, the index has formed a strong bullish candle at the support of 20 DEMA the index managed to breach the initial horizontal resistance level of 48,300 and closed above it. RSI is gradually moving in the north direction indicating good strength in the index.

• For Friday's trading session, 48,590 will act as an initial resistance level, and on the lower end, 48,380 will act as an initial support level,

STOCK'S IN NEWS

TECHM: The global IT services company recorded a consolidated net profit of Rs 661 crore for the quarter ended March FY24, rising sharply by 29.5 percent over the previous quarter despite a weak topline, boosted partly by other income. Revenue from operations fell by 1.8 percent sequentially to Rs 12,871.3 crore for the quarter, with dollar revenue increasing 1.6 percent and constant currency revenue reducing 0.8 percent on a sequential basis. The board has recommended a final dividend of Rs 28 per equity share for FY24.

BAJFINANCE: The leading non-banking finance company has reported net profit of Rs 3,825 crore for the March FY24 quarter, growing 21 percent over the corresponding period of the last fiscal. Net interest income grew by 28 percent year-on-year to Rs 8,013 crore for the quarter, with the number of new loans booked rising 4 percent to 7.87 million and customer franchises increasing 21 percent to 83.64 million during the same period.

INDUSINDBK: The private sector lender has registered a 15 percent on-year growth in standalone net profit at Rs 2,347 crore for the quarter ended March FY24, driven by lower provisions for bad loans and higher pre-provision operating profit. Net interest income increased by 15.1 percent year-on-year to Rs 5,376.44 crore for the quarter.

ECONOMIC NEWS

- India's services exports jumped 11.4 per cent to USD 345 billion in 2023 despite global economic uncertainties, while China's shipments from the sector contracted by 10.1 per cent to USD 381 billion, according to a UNCTAD report. Sectors that contribute to India's services export growth include travel, transport, medical and hospitality. With an 8.9 per cent annual rise in current dollar value terms, the world services exports surpassed USD 7.9 trillion in 2023, a quarterly bulletin of UNCTAD said.
- Russian Chamber of Commerce and Industry has opened its office in Mumbai to give a boost to the bilateral trade between Russia and India amid big number of Russian entrepreneurs seeking partners in the country. The Honorary Representative of the Chamber of Commerce and Industry (CCI) of Russia on Thursday opened the new office in Mumbai. CCI President, Sergey Katyrin, who is currently heading a Russian delegation of entrepreneurs in India, inaugurated the new office by cutting the ceremonial ribbon alongside prominent Indian officials.
