- In Monday's trading session, the Nifty opened on a positive note and gradually moved northward during the first half of the session. In the second half, the index traded sideways, which helped it close on a positive note.
- On a daily scale, the index has formed a strong bullish candle and continues to maintain its bullish structure, forming a higher high and higher low pattern. The index also trades above the 20 DEMA, indicating sustained strength. However, the RSI is trading in the overbought zone, which is a cautious sign for the bulls.
- For Tuesday's trading session, 25,915 will act as an initial support level, while on the higher end, 26,005 will act as an initial resistance level.

The index also trades along with the support of the 20 DEMA, which is a positive sign for the bulls. However, the RSI has entered the overbought zone, which is the only cautious sign for the bulls.
- For Tuesday's trading session, 58,215 will act as an initial resistance level, while on the lower end, 57,945 will act as an initial support level.

STOCK'S IN NEWS

PVRINOX: PVR Inox expects record quarterly footfalls at its multiplexes for the rest of the fiscal year, banking on promotions, federal tax cuts and a strong content slate to draw moviegoers. A pipeline of hits - both from Hollywood and Bollywood - have brightened prospects in 2025 for multiplex operators including PVR Inox, which logged record footfalls during the July-September quarter with a 15% year-on-year increase to nearly 45 million people.

SONACOMS: Sona BLW Precision Forgings reported an 19% increase in consolidated net profit to Rs 170.47 crore in the September quarter, riding on electric vehicle traction motor and railway business in India. The company, which had posted a consolidated net profit of Rs 143.58 crore in the same quarter last fiscal, said its proposed joint venture in China with Jinnaite Machinery Co Ltd (JNT), announced in July this year, has been put in abeyance.

MAZDOCK: Mazagon Dock reported a net profit of Rs 749 crore in the second quarter, while revenue was up about 6% to Rs 2,929 crore. The company has also declared an interim dividend of Rs 6 per share.

ECONOMIC NEWS

- The Central government has approved a significant procurement plan for pulses and oilseeds. Farmers in Telangana, Odisha, Maharashtra, and Madhya Pradesh will benefit from this initiative. Over Rs 15,000 crore will be spent to purchase crops for the Kharif 2025-26 season. This move aims to ensure better returns for farmers and boost agricultural production.
- India's crude oil imports from the United States surged in October to their highest point since 2022. This increase is driven by favorable economics and India's strategy to diversify its oil sources. Refiners are booking more US grades to balance supply security and geopolitical considerations. Russia remains India's top supplier, but the US share is growing.


