- In Tuesday's trading session, the Nifty opened on a negative note and remained under pressure throughout the session, which resulted in a negative closing.
- On a daily scale, the index has formed a strong bearish candle and failed to sustain above the 20 DEMA, as well as the horizontal support level, indicating weakness in the near term. The RSI is gradually moving southward, further signaling bearish momentum in the index.
- For Thursday's trading session, 25,580 will act as an initial support level, while on the higher end, 25,690 will act as an initial resistance level.

- In Tuesday's trading session, the banking index opened on a negative note and gradually moved southward, resulting in a negative closing.
- On a daily scale, the index has formed a small bearish candle but managed to hold both the horizontal support level and the support of the 20 DEMA, indicating resilience at lower levels. However, the RSI is gradually moving southward, suggesting weakness in the index.
- For Thursday's trading session, 57,725 will act as an initial support level, while on the higher end, 58,010 will act as an initial resistance level.

### STOCK'S IN NEWS

**PAYTM**: Fintech player Paytm Ltd on Tuesday reported 98% decline in its consolidated net profit at just Rs 21 crore in the second quarter, compared with Rs 928 crore in the last year period. Before one-time charge for full impairment of Rs 190 crore loan to its JV First Games Technology, PAT stood to Rs 211 crore. Revenue from operations, meanwhile, increased 24% year-on-year (YoY) to Rs 2061 crore, led by increase in subscription merchants.

**TATAPOWER:** Tata Power Company Ltd (TPCL) will invest Rs 11,000 crore in setting up a pumped hydro storage (PSP) project in Shirawta in Pune, Maharashtra, CEO and MD, Praveer Sinha told ET. Last year Tata Power Ltd. and the Government of Maharashtra signed a Memorandum of Understanding (MoU) to develop two large Pumped Hydro Storage projects (PSP) with a combined capacity of 2,800 Megawatts (MW) in the state.

**INDIGO:** Aviation major IndiGo slipped into a loss of Rs 2,582 crore in the September quarter as against a profit of Rs 2,176 crore in the preceding June quarter. However, when compared with the year-ago period, the airline's loss widened from Rs 987 crore. Revenue from operations, however, increased 9% year-on-year (YoY) to Rs 18,555 crore.

- India's rapeseed planting is set for a record high, driven by robust Chinese demand for rapeseed meal and favorable rainfall. This surge in production is expected to help the world's largest edible oil importer reduce costly overseas purchases. Farmers are planting more due to profitable returns from last year's crop.
- New Zealand's Prime Minister Christopher Luxon highlighted that people-to-people connections and labor mobility discussions are central to the proposed free trade agreement with India. He indicated New Zealand is open to welcoming more overseas individuals, including students. Both nations see significant benefits from the deal, with potential for growth in defense, security, and space sectors
