JUBLFOOD : The Domino's Pizza brand operator in India, reported strong revenue growth, with consolidated revenue from operations rising 19.1% year-on-year to ₹25,058 million in Q4FY26, while standalone revenue grew 6.2% YoY to ₹16,860 million.

IRFC : The Navratna CPSE under the Ministry of Railways, announced that it has sanctioned and fully disbursed a ₹1,000 crore term loan to Maharashtra State Power Generation Company Limited (MAHAGENCO).
