


NIFTY - 25,069.20 (Daily Chart)



- In Monday's trading session, the Nifty opened on a flattish note and gradually moved south, resulting in a negative close.
- On the daily scale, the index has formed a small bearish candle near the horizontal resistance level of 25,150. A decisive breach and sustained move above this resistance will be crucial for the index to resume its upward journey.
- For Tuesday's trading session, 25,060 will act as an initial support level, while on the higher end, 25,150 will serve as a major resistance level.



BANK NIFTY - 54,887.85 (Daily Chart)



- In Monday's trading session, the banking index opened on a positive note but moved sideways for most of the day, resulting in a flattish close.
- On the daily scale, the index has formed a doji candle, reflecting indecisiveness among market participants. The positive takeaway for the bulls is that the index continues to trade above the 20 DEMA level, which supports the near-term trend.
- For Tuesday's trading session, 54,760 will act as an initial support level, while on the higher end, 55,010 will serve as an initial resistance level.

WIPRO: The IT services company announced an expanded partnership with CrowdStrike to launch Wipro CyberShield MDR, an Al-powered unified managed security service (MSS) that simplifies and strengthens enterprise security operations.

ADANIENT: The company has received a Letter of Award (LoA) from the National Highways Logistics Management (NHLML) for building the ropeway project connecting Sonprayag with Kedarnath. The company will invest Rs 4,081 crore in its first ropeway project between Sonprayag and Kedarnath.

ECONOMIC NEWS

- India's unemployment rate witnessed a decline, reaching 5.1% in August 2025, signaling a positive trend in the labor market. The Periodic Labour Force Survey (PLFS) data, released by the Ministry of Statistics and Programme Implementation (MoSPI), indicates a continuous decrease from 5.6% in June and 5.2% in July, reflecting signs of recovery.
- India's wholesale price index (WPI) inflation saw an increase in August, reaching 0.52 per cent year-on-year, according to Commerce Ministry data. This marks a shift from the -0.58 per cent recorded in the previous August. The rise is attributed to slight increases in the prices of food, mineral oils, crude petroleum, natural gas, and basic metals manufacturing.


