• In Wednesday's trading session, the Nifty witnessed a muted performance, remaining rangebound throughout the day and ending with a flat close.

• On the daily chart, the index formed a Doji candle, reflecting indecision in the market. It continues to face resistance at the 20-day exponential moving average (20 DEMA), which remains a key hurdle for the bulls. The RSI is moving sideways, indicating a neutral momentum setup.

• For Thursday's trading session, 25,255 will act as the initial resistance level, while 25,185 will serve as the initial support level.

#### BANK NIFTY – 57,168.95 (Daily Chart)



• In Wednesday's trading session, the banking index opened on a positive note but failed to gain bullish momentum, resulting in a flattish close.

• On the daily scale, the index formed a spinning top candle, which is a neutral candlestick pattern indicating indecision among market participants. The index continues to trade sideways, hovering within the range of 56,635–57,630, and a breakout on either side is required to establish a clear directional trend. Positively, the index continues to trade above the 20day exponential moving average (20 DEMA), which favors the bulls.

• For Thursday's trading session, 57,080 will act as an initial support level, while 57,280 will act as an initial resistance level.

#### STOCK'S IN NEWS

**TECHM :** Tech Mahindra on Wednesday reported a 2.2% sequential decline in net profit for the first quarter of the fiscal at Rs 1,141 crore. Revenue for the quarter under consideration was down 0.2% to Rs 13,351 crore quarter-on-quarter.

**ANGELONE :** Angel One announced its Q1 results reporting a 60 per cent YoY decline in its PAT. Likewise, the company's revenue also declined by 18 per cent on a YoY basis for the quarter. The company further updated in a regulatory filing that its client Funding Book reached an all-time high of ₹ 48 billion as of June 2025 while unique SIPs registered surged by 0.9% QoQ to 1.9 million.

**GODREJPROP** : The real estate developer has announced its entry into Raipur through the acquisition of 50 acres of land. Development on this land will primarily consist of premium plotted residential units, offering an estimated saleable area of 9.5 lakh square feet.

#### **ECONOMIC NEWS**

- NATO Secretary General Mark Rutte has threatened India, China, and Brazil with 100% secondary sanctions if they continue trading with Russia. He urged these nations to pressure President Putin for serious peace talks with Ukraine.
- India's retail inflation hit a six-year low, but state-wise data reveals significant variations. Ten states and union territories, including Kerala, Punjab, and Jammu & Kashmir, experienced inflation rates exceeding the national average of 2.7% in the first quarter. Food, fuel, and personal care costs were key drivers, with differing statelevel weights contributing to the upward bias.
