# NIFTY – 24,781.10 (Daily Chart)



• In Monday's trading session, the Nifty opened on a positive note but was soon overtaken by bearish pressure, causing it to lose its initial gains. The index remained under pressure throughout the session and closed negatively.

• On the daily chart, it formed a bearish candle at the 20 DEMA resistance level. The RSI continues to trade below the midline, signaling weakness in the index. The Nifty needs to break and sustain above the 20 DEMA to resume its upward momentum.

• For Tuesday's trading session, 24,710 will act as the initial support level, while 24,885 will serve as the initial resistance level.

### BANK NIFTY – 51,962.70 (Daily Chart)



• In Monday's trading session, the banking index opened with a gap-up but quickly filled the gap and moved sideways for the rest of the session.

• On the daily chart, the index formed a bearish candle, indicating dominance by the bears. However, a positive note for the bulls is that the index managed to close above the 20 DEMA level, which can act as a key support.

• For Tuesday's trading session, 51,850 will serve as the initial support level, while 52,230 will act as the initial resistance level.

**EICHERMOT :** Royal Enfield has commenced operations of its manufacturing unit (Category 2) and flagship showroom in Bangladesh. The company has set up business in collaboration with IFAD Motors in Bangladesh. The new manufacturing facility is Royal Enfield's sixth assembly unit outside India, following Nepal, Brazil, Thailand, Colombia, and Argentina.

**CUB** : Private sector lender City Union Bank on Monday reported a net profit of ₹285.2 crore for the second quarter of FY25, showing a modest 1.6% growth compared to ₹280.6 crore in the corresponding quarter last year. Net interest income (NII) for Q2 FY25 rose by 8.2%, reaching ₹582.5 crore, up from ₹538.4 crore in the same quarter last year. In comparison, NII growth in Q1 FY25 was 4.5%, with the bank recording ₹546 crore.

**UNIONBANK** : Public sector lender Union Bank of India (UBI) reported a significant 34% year-onyear increase in consolidated net profit for the second quarter of FY2025, reaching ₹4,720 crore, compared to ₹3,511 crore in the same quarter last year. CMP- 4,810.45 IMPACT- **POSITIVE**

#### **ECONOMIC NEWS**

- Finance Minister Nirmala Sitharaman on Monday said India is poised to continue its growth trajectory and is likely to become the world's third-largest economy by 2027. India currently is the fifth largest economy in the world with a GDP of around USD 3.9 trillion. Addressing the Roundtable on 'Investment Opportunities in India' at the New York Stock Exchange, the oldest and the largest stock exchange in the world, the Finance minister said India is poised to continue its sustained growth trajectory and enhance its contribution to global growth significantly.
- The cumulative rate hikes of 2.5 percentage points by the central bank since May 2022 negatively impacted headline inflation by 1.60 per cent, a paper by senior RBI staffers said on Monday. "Policy rate increases have anchored inflation expectations and modulated aggregate demand, generating disinflationary responses," the paper by Deputy Governor Michael Patra, Indranil Bhattacharyya, Joice John and Avnish Kumar, said.
